

This proposal was designed to satisfy the needs of New Orleans Investment Conference by providing the technical expertise and hardware required for the implementation of an On-site Fast Track ™ Registration & Electronic Lead Retrieval.

It is the understanding of ATS that New Orleans Investment Conference is currently without the capability to produce a show badge with an encrypted QR code in-house. Listed below are items ATS will provide to help New Orleans Investment Conference complete these services in a successful manner at the 2019 New Orleans Investment Conference.

- ATS will provide the New Orleans Investment Conference with a copy of ATSReg™ onsite registration & Fast Track™ software for onsite badge production. This software will produce a badge with an encrypted QR Code configured to the Trade Show Exhibitor Association (TSEA) standard (i.e. ID, name, title, company, address 1, address 2, city, state, phone, and e-mail).
- ATS onsite techs will set up registration 24 hours prior to or at an agreed time scheduled opening and maintain system during all / open registration hours. ATS techs will arrive onsite each day one hour before Registration opens.
- ATS will provide a state-of-the-art electronic Lead Retrieval system that will include battery powered PDA, Tablet, and Mobile App options to 2019 New Orleans Investment Conference exhibitors.
- ATS will provide trained technicians to complete the distribution, service, and pickup of lead
 equipment at the close of 2019 New Orleans Investment Conference.

SUMMARYOR SERVICES

FastTrack™ Automated Check-In & Badge Production

ATS suggests the use of Fast Track automated check-in and badge printing system for onsite registration. Included in the email confirmation the attendee receives, there will be a QR Bar Code that will contain the registrant's unique registration ID number. When the exhibitor or attendee arrives at your event with their printed confirmation, they can go to one of the Fast Track stations, scan their QR Bar Code and their badge & credentials will print out automatically. This can drastically reduce attendees time spent in line allowing them for more time spent attending your event.

On-Site Registration Overview

ATS will employ <u>one onsite registration managers</u> to setup and maintain the onsite registration system. This onsite management team will train all New Orleans Investment Conference temp staff on the functionality of the onsite program, making themselves available to answer any questions, and help register attendees throughout the event.

- Processing onsite will require New Orleans Investment Conference to acquire from the facility, a dedicated high-speed internet connection for the registration area to facilitate real-time credit card processing.
- ATS will employ Zebra Brand high speed thermal transfer badge printers for the creation of show badges at the 2019 New Orleans Investment Conference. These printers are the highest quality allowing the printing of a single show badge and additional event tickets.
- Show badges created will contain a QR Barcode with all vital attendee contact information. This barcode can be printed either on the front of the badge or onto a second piece to be flipped to the back or detached for use as a true electronic business card.

ATS can place any information collected during the registration process onto the show badge such as registration type, membership, ribbon codes, session codes, etc.

• ATS will provide for all costs generated by shipping all show related equipment (i.e. laptops, printers, badge stock, scanners, etc.).

Exhibitor Services

New Orleans Investment Conference will provide one (1) exhibitor service desks with header, 10 amp fourplex electrical power, one (1) chairs, a wastebasket and a 100 square foot draped work area behind or next to counter. ATS can make adjustments to this work area to match what is provided overall by the decorator.

- ATS will not require an internet connection at the exhibitor service desk.
- Knowledgeable ATS technical staff will attend the service desk during all set-up and show hours.

ATS will have at least one (1) full time staff persons' onsite for service and technical support at the 2019 New Orleans Investment Conference. As a rule of thumb, ATS will provide one (1) ATS staff person per eighty (80) units rented.







TE TERMS AND CONDITIONS

Payment for web based registration services due within (30) days of the web page initial launch day.

In the event New Orleans Investment Conference determines that ATS is not providing the services as outlined in this agreement, New Orleans Investment Conference will notify ATS in writing. This written notification will detail the performance deficiencies allowing ATS ten (10) business days to respond to New Orleans Investment Conference in writing with a revised operation plan that will address and correct the deficiencies outlined. If New Orleans Investment Conference determines the revised operation plan to be insufficient, New Orleans Investment Conference will have the option to optout of the agreement period. ATS must receive notice of a desire to cancel within (60) days prior to the event.

ATS will inform Exhibitors via e-mail and broadcast fax of the lead collection system and services available. New Orleans Investment Conference will provide ATS a list of exhibitors including address, phone, fax numbers, and email addresses in digital form.

New Orleans Investment Conference will have security in place during overnight hours to ensure equipment security.

New Orleans Investment Conference will provide for electrical and internet (if needed) at Registration.

ATS carries and will provide proof of the following insurance and amounts: Commercial General Liability Certificate of Insurance showing combined single limit of liability in in the amounts of \$1,000,000 per occurrence/\$2,000,000 general aggregate. The certificate of insurance must include on-site data loss protection, by naming New Orleans Investment Conference the loss payee. The additional insured should be listed as New Orleans Investment Conference and the event facility with respect to their vicarious liability.

ACCEPLANCE

This acceptance confirms that New Orleans Investment Conference accepts ATS as the Official Registration and Electronic Lead Retrieval Services Provider for the 2019 New Orleans Investment Conference.
